

Equipment Hire Terms and Conditions

These Terms and Conditions govern the hire of equipment provided by Act Belong Commit® to approved partners (“the Hirer”). By accepting and using Act Belong Commit equipment, the Hirer agrees to the following:

1. Eligibility

- Equipment hire is available to current Act Belong Commit partners only.
- Hirers must have a signed partnership agreement with Act Belong Commit.

2. Booking and Collection

- All hire requests must be submitted via the Signage Loan Request Form on the Act Belong Commit Partnership Portal.
- Bookings are not confirmed until written approval is provided by Act Belong Commit.
- Equipment is subject to availability and allocated on a first-come, first-served basis.
- The Hirer is responsible for collecting and returning equipment at the agreed time and location, unless otherwise arranged with Act Belong Commit.

3. Inspection and Acceptance

- The Hirer should inspect all equipment upon collection.
- Any faults or missing items must be reported to Act Belong Commit immediately.
- By accepting the equipment, the Hirer acknowledges it is in good working order and suitable for use.

4. Use of Equipment

- Equipment must only be used for approved partner activities that align with the Act Belong Commit mental wellbeing framework.
- Equipment must not be loaned, sub-hired, or used for commercial purposes without written consent from Act Belong Commit.
- The Hirer must ensure that equipment is used safely and in accordance with any provided instructions.

5. Care and Responsibility

- The Hirer is responsible for the equipment from the time of collection until it is returned to Act Belong Commit.
- Equipment must be returned in the same condition it was hired, with all parts and accessories intact.
- The Hirer is responsible for ensuring equipment is not lost, stolen, damaged, or exposed to inappropriate conditions (e.g., weather, misuse).

6. Damage, Loss, or Theft

- The Hirer must notify Act Belong Commit immediately if equipment is damaged, lost, or stolen.
- The Hirer may be liable for repair or replacement costs, at Act Belong Commit's discretion.
- Act Belong Commit reserves the right to recover reasonable costs incurred due to misuse, negligence, or failure to return equipment.

7. Return of Equipment

- Equipment must be returned by the agreed date and time to an Act Belong Commit staff member.
- Late returns may impact future eligibility to hire equipment.
- Act Belong Commit reserves the right to charge a fee for significantly delayed returns.

8. Liability and Indemnity

- The Hirer uses the equipment at their own risk.
- Act Belong Commit accepts no responsibility for any injury, loss, or damage arising from the use of hired equipment.
- The Hirer indemnifies Act Belong Commit against all claims, damages, or costs resulting from misuse or negligence in relation to the equipment.

9. Cancellations

- Hirers must notify Act Belong Commit of cancellations as soon as possible.
- Act Belong Commit reserves the right to cancel or withdraw hire arrangements at its discretion (e.g. due to unforeseen circumstances or partner ineligibility).

10. Privacy and Data

- Any personal information collected through the hire process will be handled in accordance with the Act Belong Commits' Privacy Policy and applicable by privacy laws.
- Contact information provided by the Hirer may be used for Act Belong Commit communication regarding the hire or related partner activities.

11. General

- Act Belong Commit reserves the right to amend these Terms and Conditions at any time.
- Continued use of equipment after such amendments constitutes acceptance of the updated terms.
